stallion INVITED TO THE DANCE, for the 2015-breeding season. The stud fee shall be <u>\$950</u>. Payable to Vanessa Froman.

- 1. Mare owner agrees to pay \$15.00 per day for mare care dry and \$18.00 per day for mare care wet. Payable to Fedore Large Animal Veterinary Services.
- 2. There will be a \$250 chute fee with this contract, to include first shipment. Payable to Fedore Large Animal Veterinary Services. If mare comes to the property chute fee is \$150.
- 3. Shipped semen is available and shipped at \$175 a shipment after first shipment. Any semen delivered on Saturdays will be charged an additional \$25 shipping fee. Container will be returned to Fedore Large Animal Veterinary Services within 7 days. No shipments will be made without stud fee and applicable chute fee paid. A pick up fee of \$75 will be charged for any semen picked up at the clinic or delivered. Shipments will be billed within 10 days of shipping and are due upon receipt. If not paid no further shipments will be made.

4a. All shipments will use boxes. Equitainers are available upon request for an additional fee of \$25 payable to Fedore Large Animal Services.

- 4. Without 24 hours notice, JVCC Ventures and Fedore Large Animal Veterinary Services cannot guarantee shipment of semen to mare owner. Notice shall be the mare needs semen or that the mare is being checked. Notice shall be given to Fedore Large Animal Veterinary Services via phone call. Collections are made Monday, Wednesday, and Friday.
- 5. Mare shall be in a healthy and sound condition, free from infections, contagious and transmittable diseases. A current coggins test and a photocopy of registration papers will be given to stallion owner when mare is delivered.
- 6. This contract contains a "live color foal guarantee". A live foal is described as a newborn foal, which stands and nurses without assistance. If foal is born dead, there are return privileges for the 2016 season only if stallion owner is notified within 5 days and receives a veterinarian's statement confirming death. If after being pronounced "safe in foal" the mare should miscarry, abort or prove barren, mare owner has the privilege to return for the remainder of 2015 season or return in the 2016 breeding season. A \$200 rebreed fee will be charged for all contracts carried to 2016.
- 7. A "Breeder's Certificate" will be issued for the foal, conceived by this mating, when stallion fee, all expenses have been paid in full and a live foal has been produced.
- 8. Both parties agree that JVCC VENTURES, Fedore Large Animal Veterinary Services, Vanessa and/or John Froman, their agents and employees are not liable for accident, sickness or death to above named mare while in the care of stallion owner and/or breeding management. Fedore Large Animal Veterinary Services will exercise the best judgment in care and supervision of mare and/or foal.
- 9. If mare dies or is sold, JVCC VENTURES, the stallion owner, has the option to accept a substitute mare.
- 10. Mare owner agrees to pay for any and all veterinary costs incurred during the time mare is at Fedore Large Animal Veterinary Services. Veterinary care may be administered at the discretion of breeding manager.
- 11. This contract is non-assignable and non-transferable.
- 12. When both the stallion owner and the mare owner sign this contract it will then be a binding contract subject to the above terms and conditions. This contract is entered into in the state of Michigan and will be enforced under laws of Michigan.
